- The Fiber Arts Market will be in the Sequim Middle School Cafeteria is ground level. There are ramp entrances to the building. The address is 301 West Hendrickson Road, Sequim, WA 98362.

- The Fiber Arts Market will be open for setup from 7:00 to 9:00 AM on Saturday.
- The breakdown is 5:01 to 7:00 PM.
- It will be open for business 9:00 AM – 5:00 PM.
- 8' x 8' spaces are available at \$40. Cafeteria tables are available that are 8' x 16" surface table with an attached 8' x 1' bench (the bench can be folded down). Please note on your application if you want to use these tables for your space and how many. You will have to provide your own chairs.
- Please bring table coverings, no linens are supplied.
- Each vendor is required to do their own cleanup. We need to leave our spaces as clean as we found them, "leave no trace".
- Vendor applications will be processed as received; due to limited space, preference is being given to returning vendors with the most directly appropriate wares. Applications are being accepted now and initial applicants will be notified in September.
